**6.2 Guest Speaker – Gallivan: Student Health & Wellness**

Bryan Boechler, Client Services Director with Gallivan: Student Health & Wellness was welcomed to our council meeting to provide the Councillors with information on how the plan is selected, how the cost is determined and what services they provide to us. The student benefit plan covers 3 areas: health, dental and vision. Bryan shared that the most utilized portion of the health plan comes from prescriptions at 66.3%, followed by practitioners (chiropractors, psychology, massage, etc) 18%. With the dental portion, dental exams are 57.8%, followed by fillings at 31.8%. Of the approximate 4600 students on campus, in Fall 2017 the student health & dental plan had 1985 students enrolled in the health plan and 2000 enrolled in the dental plan. Bryan shared stats on student interactions in Karen's office – 5556 in 2016-2017, in the Fall of 2017 2710 student visited the office. The web visits for 2016-2017 come in at 4718, and for Fall of 2017 at 1227. The following chart shows how much each student on the health plan pays, how much the Students' Association pays, and the difference. The Students' Association is paying an additional \$2.28 for each student on the plan.
